WHEREAS, a portion of the land that is subject to the Declaration and the Plat as more particularly described in Exhibit "A" attached hereto and incorporated herein ("Tracts 300 and 307"), has been dedicated to the Lakewood Ranch Stewardship District and is intended to be dedicated to Manatee County as a public roadway known as Uihlein Road; and

WHEREAS, Manatee County has requested that Tracts 300 and 307 be withdrawn from the Declaration prior to accepting such dedication for the future roadway known as Uihlein Road; and

WHEREAS, pursuant to Section 18.10 of the Declaration, the Declarant reserved the unilateral right to withdraw any property from the jurisdiction of the Declaration, for so long as Declarant holds any property for sale in the ordinary course of business with the Community; and

WHEREAS, Declarant holds property for sale in the ordinary course of business within the Community; and

WHEREAS, the Declarant is desirous of withdrawing Tracts 300 and 307 from the Declaration pursuant to its reserved rights to amend the Declaration and withdraw lands.

NOW, THEREFORE, the Declarant hereby withdraws Tracts 300 and 307 from the Declaration.
